DISCIPLINARY BEHAVIOUR AND CONDUCT OF THE STUDENTS

- 1. Express yourself without using rude words or making offensive gestures.

- 3. Show respect for others by refraining from teasing and humiliating.

- 17. Students should only throw debris in the bins provided across campus, like in classrooms, hostels, and offices.
- 18. Any criminal activity or breaking the law on the college campus will be reported to the police.
- 19. If a student commits a crime under Indian law, they may be suspended or expelled from the college.
- 20. Students facing criminal charges or suspension must get permission from the proper authority before entering the college campus.
- 21. Be on time for all classes. Students who arrive late won't get attendance credit and might not be allowed in.
- 22. Be prepared for class with the appropriate materials and assignments completed.
- 23. Students should keep the class rooms tidy. They should switch off lights and fans when they are not required.
- 24. Malpractice of any kind will not be allowed during the Laboratory classes / internal / University Examination.
- 25. All students have to attend laboratory classes with full presentation.
- 26. Records should be brought and instructions should be followed accordingly.
- 27. Students are not permitted to use mobile phones in any of the academic area (class room, Library, Computer Centre, Examination Halls, etc.). Mobile phones with camera facilities
